Minutes of the Events and Tourism

It was noted that Cllr Falat is a Yacht Club member and has outside links to the powerboats and dragon boats.

ET35. Minutes To approve the accuracy of the minutes from 29th October 2018. Proposed as an accurate record by Cllr Falat and seconded by Cllr Ashdown.

ET35.1 To discuss outstanding actions from last meeting.

ET23 Cllr Falat to provide wording for the Powerboat invoice: still outstanding.

ET24. Clerk to arrange a meeting with S Shappelle: Still chasing.

ET25. Clerk to arrange a meeting with the Arts Circle: Waiting for the bowls to provide their dates for the season.

ET27. Cllr Falat to contact the schools regarding playing in the bandstand on Saturdays: There has been change of staff at Denes High School. It was decided to allow the schools to come to Council.

ET28. Clerk to set up a meeting in February for the Tennis Club and contact Norse regarding the condition of the courts: The court surface has been done on the public courts but not the blue ones. It was decided it would be best to do again at the beginning of the season. **Action Clir Pullen** to provide contact details.

ET30. Cllr Falat to write a Memorandum of Understanding for FoNEP: Still outstanding.

ET36. To discuss the Nearly Music Festival with Intuitive Solutions and guests and agree any action: The Nearly Music Festival will incorporate Charity and Local businesses. Start Midday and close about 9 – 9.30pm on Saturday and 8 – 8.30pm on Sunday. Premises Licences will be a maximum of 1500 adults and 500 children. The team has managed events for 3 years. The stage will back on to the yacht club. The barriers will be around the green area and not a closed park. This will not stop access to the Museum, Park Café or Yacht Club. Cllr Pullen, stated that there are no issues with fishermen, they will not be fishing that weekend.

RH mentioned that he could help with barriers and emptying of bins. This discussion would be made out of meeting.

Norse to empty the public toilets before the event.

Action CIIr Pullen to contact Powerboats, there could be joint advertising.

The team will provide their own generators.

The PA system could be used for a crowd emergency. Yacht Club to sort out handover and testing.

Advertising should include "by king permission of Nicholas Everitt Park Trustees and OBPC". **Action Cllr Falat** to design a leaflet for the North side of the broad, to include dredging, festival and the cinema. Also, to speak to the Wherry Hotel. Letter to be done in February.
